### **Appointments within Groupe ADP**

Augustin de Romanet, Chairman & Chief Executive Officer of Aéroports de Paris SA – Groupe ADP, has made the following appointments:

# Clément Beaune has been appointed Deputy Chief Executive Officer of Aéroports de Paris Management.

Clément Beaune, 35 years old, is a former student of Sciences Po, Paris, the College of Europe and the Ecole Nationale d'Administration (ENA).

Between 2009 and 2011, Clément Beaune worked at the Budget Directorate, in the "budget acts" bureau. Between 2011 and 2012, he joined the "research and higher education" bureau at the Budget Directorate within the Ministry of the Budget, Public Accounts and Administrative Reform. Between 2012 and 2014, Clément Beaune was technical advisor on budgetary affairs in the Prime Minister's Office. From 2014, he worked in the Office of the Minister of the Economy, Industry and the Digital Sector where he served as advisor for European and budgetary affairs, and, later, as senior advisor to the minister, in charge of European, international and financial affairs.

#### Frédéric Guzy has been appointed Deputy Director of Human Resources for Groupe ADP

Frédéric Guzy, 43 years old, holds a post-graduate degree in "labour market analysis, organisation and employment management" from the University of Paris Ouest (Paris 10) and a master's degree in economics from Paris Diderot University (Paris 7).

He began his career in 1998 as a project manager at Groupe ISS France, where he was in charge of implementing the reduction in working time. Between 2000 and 2014, he worked for RATP (the Paris public transport operator) as Head of Human Resources for a number of sectors within the company. During this time he was involved in transforming the job roles of staff working in train maintenance, IT systems, customer relations and passenger checks.

Since September 2015, he has been an advisor to the Minister of Labour, Employment, Vocational Training and Social Dialogue, responsible for businesses and occupational health.
