The methods for the provision and consultation of the information contained in article R.225-83 of the French Commercial Code, relating to the Ordinary General Meeting of 16 May 2013

The Aéroports de Paris General Meeting of Shareholders will take place on Thursday 16 May 2013 at 3 p.m. in the Bordeaux amphitheatre of the Porte Maillot Palais de Congrès, 2 place de la Porte Maillot, 75017 Paris.

For holders of bearer shares, the exercise of this right is subject to submission of a shareholding certificate delivered by the authorised financial intermediary;
- all shareholders may consult these documents at the company head office as from the time the meeting is called, and during a minimum period of 15 days before the date of the General Meeting.
