

# **TAV AIRPORTS**

Groupe ADP holds a 46.12% stake in the Turkish airport operator TAV Airports, which is the largest airport operator in Turkey. TAV Airports has established itself as the market leader in airport services in the Middle East and North Africa.

TAV Airports is involved at each stage of the airport value chain: its subsidiaries are active in the areas of retail (landside and airside), food and beverage, ground handling, lounges management, security, operational services and information systems.

At end of June 2018, TAV Airports manages a portfolio of fifteen airports in six countries, including Istanbul Ataturk, Ankara Esenboga and Izmir Adnan Menderes in Turkey, as well as airports in Tunisia, Georgia, Macedonia, Croatia and Saudi Arabia. In May 2018, TAV Airports gained concession of Antalya in Turkey.

Groupe ADP and TAV Airports aim at fostering cooperation and coordination between both groups, especially for expansion in fast growing areas such as the Middle East, Africa and Asia.





# **BEIJING DAXING AIRPORT, CHINA**

#### PROJECT /

- Architecture design of the first megaterminal at the new Beijing Daxing
   International Airport won by ADP Ingénierie.
- ♦ The unique centralised terminal design offers:
  - vertical superposition of the international and domestic levels;
  - Shorter, simpler passenger journey, greater comfort and easy access to the many services on offer, as well as operational savings for the airport operator.

#### PROJECT /

- Through ADP Ingénierie: Architecture design and supervising the construction works since 2014 of the new Bahrain International Airport passenger terminal. Delivery planned in 2020.
- Design and supervision of the new Regional Air Traffic Center won by ADP Ingénierie in March 2017.

#### **ACHIEVEMENTS AND BENEFITS /**

- State-of-the-art facility: not constrained by the geometry of the old building and designed to the best standards.
- Passenger experience improved: removal of operations interface in saturated facility and construction works.
- Risk control: simplified phasing, reduction of total costs and time schedule.
- An optimised master plan: possible reuse of the old terminal after renovation, following the transfer of traffic.


