- ◆ **Henri-Michel Comet**, 61, is a former student of the Ecole nationale d'administration (ENA). He also has a Master's degree in Public Law and a degree from the Institute of Political Studies (IEP) in Paris.

Throughout his career, he held various positions in the Corps of Prefects. From 2004 to 2005, he was Deputy Director in the office the Minister of the Interior, Domestic Security and Local Autonomy. From 2005 to 2007, he was appointed Advisor to the cabinet of Prime Minister.

Between 2007 and 2009, Henri-Michel Comet was Prefect of the Picardie region and Prefect for the Somme, and from 2009 to 2011, he was Secretary General to the Minister of Interior, overseas collectivities. From 2011 to 2014, he was appointed Prefect of the Midi-Pyrénées region and Prefect for Haute-Garonne. In 2014, he was appointed Prefect of the Pays de la Loire region and Prefect for Loire-Atlantique. Then, in 2017, he was appointed Prefect of Auvergne-Rhône-Alpes, Prefect for Defence and Homeland Security for the south-east region.

- ◆ **Patrick Collard**, 64, held several positions in press groups. From 1997 to 2005, he was CEO of Télérama (public limited company) and was then appointed as Chairman and CEO of the advertising agency subsidiary Publicat. From 2005 to 2008, he was COO of the daily newspaper Le Monde, CEO and Chairman of Monde Publicité (public limited company).

In 2008, he joined the Groupe La Dépeche du Midi as COO, before being appointed, in May 2009, COO of Radio France, a position he left at the end of 2012. Vice-President of the Long Thibaut Crespin Foundation, Patrick Collard then joined the Executive committee of Groupe ADP as Deputy Director for the Chairman and Chief Executive Officer. He is also Vice-President of the UAF and Administrator of the Aéroclub de France.

- ◆ **Régis Lacote**, 45, is a graduate of ESIEE and ENAC and has been General Manager of airside operations at Paris-Charles de Gaulle since 2012.

He started his career in 1998 as Security and Operations Manager at "Roland Garros" Airport in La Reunion. Since then, he held various positions within Groupe ADP: station manager, ground handling division at Paris-Charles de Gaulle Airport (2005-2008), Senior Operations Manager for Terminals 2 E/F/G and at the TGV railway station (2008-2010), Airport Operations General Manager at Paris-Orly Airport (2010-2011), then Airside Operations Senior Manager at Paris-Charles de Gaulle Airport (2011-2012).

- ◆ **Gilles Lévêque**, 58, took up his duties as Information Systems Director for Groupe ADP in 2015. He is graduate of the Institut National des Sciences Appliquées of Lyon.

From 2006 to 2015, Gilles Lévêque was Information Systems Director of GEODIS Group (French Transport and Logistics company). Prior to that, he held many positions around supply chain and information systems, at Hewlett-Packard in France and the United States of America from 1992 to 2006. Between 1988 and 1992 he was consultant and programme director for Arthur Andersen Consulting.
